IMPORTANT INFORMATION

Roommates: Trip Leader will assist, but is not responsible for finding roommates for single travelers. Space is held for singles only if they agree to pay the single-supplement if a roommate is not found. The only people allowed to stay in club accommodations are fully paid JSC members in good standing, having submitted signed trip & member applications. No exceptions to this rule.

Air Seats & Bedding: JSC will make every effort to accommodate requests for airline seating & hotel bedding configuration. However, neither the Trip Leader nor JSC can guarantee any particular airline seats or bedding arrangements.

Passengers Pursuing Personal Itineraries (PPPI): Travelers purchasing their own airfare MUST book their flight to arrive prior to the group, and to depart after or with the group to be considered for inclusion in the group ground transportation to and from the resort. Travelers booking their own air MUST send the trip leader their flight itinerary based on which the trip leader will approve or decline inclusion in group ground transportation to and from the resort. The JSC is not responsible for schedule changes of travelers that book their own airfare, and can't hold the group bus to wait for incoming flights.

Airlines / Ground Transportation: Neither the Trip Leader nor the JSC is responsible for travel delays, cancellations, or schedule changes due to strikes, weather, natural disaster, or any other circumstances. Costs resulting from travel changes (foreseen or unforeseen) are the expense of the traveler. Trip insurance is recommended to cover this cost, as well as the cost of delayed luggage.

Frequent Flyer/TSA PRE: Please add your Frequent Flyer number, global entry and/or TSA PRE number to your trip application so that it can be communicated to the tour operator. Always check your boarding pass to ensure FF and TSA PRE numbers are included.

Change Fees: Any changes made by travelers to air itineraries, lodging, lift tickets, etc. after the applicable deadlines will result in a \$100 administrative fee and the traveler(s) will be responsible for charges that result from the supplier(s).

Prices: Trip prices are subject to change due to unforeseen circumstances, such as currency exchange rates, airline, fuel, and government fees. The Trip Leader, JSC, and its agents have no control over or responsibility for such price changes. Price changes will be included in the final invoice due November 1, 2025.

PAYMENTS & CANCELLATIONS

- Travelers agree to the following payment schedule:
 - **Initial Deposit w/ Application \$1,000 pp; Second installment \$1,500 due October 1st; Trip Balance due November 1st.**
 - A \$50 pp fee applies to all late payments, to hold the JSC whole for interest charged by our vendors.
 - Credit card payments are accepted subject to the following vendor fees: 3.5% VISA & MCARD; 4% AMEX. Call TL for the form.
- Sign and Return this Trip Application Form, your \$1,000 pp deposit check (made out to the Jacksonville Ski Club), and a copy of the picture page of your passport to: **Bianca Roos, 11 North Park Circle, Palm Coast, FL 32137**
- Cancellations prior to September 1st will incur no cancellation fee. Cancellations between September 1st and November 1st will incur a \$1,000 cancellation fee. Cancellations after November 1st are non-refundable. Traveler may obtain a substitute traveler to take his/her place up to 90 days prior to departure, but the primary traveler shall be liable for the cancellation fees, single supplement for travel companion, name changes and any other fees/penalties imposed to the club.

- Trip Insurance is not included in your trip package price and is available through www.insuremytrip.com, www.travelprotectors.com or your own insurance agent/credit card company. If you need CFAR or coverage for existing medical conditions, it is recommended that you obtain travel insurance within 48 hours of your first payment.

I and all members of my family, fully understand that the JACKSONVILLE SKI CLUB (herein after referred to as the "Club") acts only as a coordinator of ski trips and other Club activities, and is NOT a Seller of Travel Services as defined by Florida Statutes Chapter 559. as amended, or any similar Federal or State statute or regulation. As such, the undersigned, on behalf of him/herself and all members of his family, and heirs, understands that the Club, as a trip coordinator, accepts no responsibility for the services or products of any person, ski area, airline, motor coach, hotel, insurance company, ski rental company, mountain resort, or organization whatsoever rendering any of the services or accommodations being offered on any trip. Ski trip and other activity fees are based upon current tariffs and exchange rates, and are subject to change without notice. The Club and Trip Leader accept no responsibility, in whole or in part, for any delay, delayed departure or arrival, missed air travel or other carrier connections, loss, damage, or injury to person or property, or any mechanical defect or failure of any nature whatsoever, or for any substitution of lodging or a common carrier with or without notice, or for any additional expenses occasioned thereby. I/we fully understand that the Club is a voluntary association run by volunteers only, who are not professionally trained in conducting ski trips or other Club activities. As such, by participating in any such trip or Club activity, I/we do not rely upon the expertise of any Director, Officer, Trip Leader, Activity Coordinator, or any of the assistants on such trip. I, and all members of my family, hereby expressly acknowledge that snow skiing, snowboarding, and similar activities are inherently dangerous, and we hereby acknowledge the hazards inherent to the sport of snow skiing or snowboarding, and hereby assume all risk of injury or damage incident to such activity. As such, I/we hereby agree that I/we are solely responsible for our personal safety and conduct, and that as a participant, my family and I hereby jointly and severally absolve, release, waive, and forever discharge any and all liability, claims, or demands against the **JACKSONVILLE SKI CLUB INC.** and **The Florida Ski Council, Inc.**, and any of its Officers, Directors, Agents, Trip Leader, and Assistant Trip Leaders which may arise out of or otherwise be related to any injury, damage, or pecuniary loss by reason of any such Club membership or activity or participation in said organization. In further consideration for the mutual benefit derived from the joint participation by membership in the Club, and participation in Club related activities, I/we fully understand that I am responsible for meeting all payment deadlines and obligations to the Club in a timely fashion. Should I/we miss any departure, I/we understand that I may not be able to recover any part of my/our trip or activity payment. Furthermore, I, and my family members, hereby agree that the club shall not be responsible for either myself or any member of my family who is denied entry into any state, territory, providence, or country because of any prior criminal convictions, civil offences, or by reason of any rules or regulations propagated by the US Department of Immigration and Naturalization Services including, but not limited to, laws and regulations governing the issuance and renewal of US Passports and/or Travel Visas. I/we agree to comply with the health and immigration requirements imposed by those countries on the trip itinerary as well as countries through which the flight itinerary connects. Furthermore, I agree to indemnify and hold harmless the Club, its Officers, Directors, Agents, Trip Leaders, and Assistant Trip Leaders from any and all loss for expenses incurred by or attributable in any way with any ski trip or other Club sponsored activity. I/we agree to abide by the By-Laws, Rules, and Regulations of the Club and the Trip Leaders in connection with any ski trip or other Club activity. Furthermore, should any dispute arise out of my Club membership or participation in any Club sponsored activity or trip, then both the Club and I agree to submit any such dispute for resolution to binding, mandatory arbitration before the American Arbitration Association (AAA) to which we agree that the then current edition of the Commercial Rules of Arbitration of AAA shall apply. Each party shall bear their own cost and expenses incident to said arbitration proceedings. I/we further agree that the venue for any such arbitration proceedings shall be Duval County, Florida unless otherwise agreed in writing by the parties. I/we further agree that the Florida law shall apply to any dispute arising out of or incident to this Agreement.
